

Licensing agreement for Pulsar's Junk Yard: Equines Asset Pack

Preamble

The term "asset pack" includes all updates, upgrades, expansions and modified versions of the 3D models included in *Pulsar's Junk Yard: Equines* and in the individual packs *The Belgian, The Centaur, The Donkey, The Zebra,* and *The Quarterhorse*.

The term "model" or "models" refers to the 3D model or models within the asset pack.

The term "licensee" refers to any individual, organization or business who purchases the asset pack.

By downloading and installing the included asset pack, the licensee agrees to the following:

Credit

For any project using the asset pack, credit must be given to: "Pulsar" E.g. "Equine genitalia by Pulsar" or similar wording. Credit should be included in the description of the post and, if used in time-based media such as animation or film, within the credits section of the video.

License and Usage Rights

Upon full payment of the agreed-upon usage fee, Pulsar Studios grants the licensee the non-exclusive, non-transferable right to use the asset pack according to the following:

• 3D assets in the asset pack may be used in projects intended for personal use including: virtual reality chat avatars, art reference, and still image renders and animations which are freely distributed.

• The asset pack may be modified by the licensee for exclusive use provided it is not resold or redistributed, including resizing, sculpting, texturing, rigging or animating, with the express intention to accommodate the needs of the licensee's project. Any media created with modified assets from this asset pack must still be credited.

• Commercial rights are limited to the following:

• For individual 3D modelling commission projects where the client is receiving a copy of the asset from the artist, both the artist and the client must purchase the model or models used in the commission. The client does not need to purchase a model if it is for rendered images or animations where they will not be receiving the model geometry.

• The models may be used for projects with limited commercial distribution including on subscription services (e.g. Patreon, Subscribe Star, Just For Fans, etc) to an audience of less than 1,000 paying subscribers.

• This license does not extend to widespread commercial release to audiences of 1,000 or more individuals or for use in media (including but not limited to animations, short films, images, and comics) which has a distribution of 1,000 or more copies.

• The asset pack may not be resold or redistributed in any way. It may not be unpackaged, separated into individual models, renamed, or modified with the intent to be resold or redistributed. It may also not be used to create derivative works for re-sale, including 3D printed sculptures or adult toys. For additional licensing
