REPLY TO DELL

1. The representations made by Edward J. Murphy, representative for Dell, have been pure fraudulent

- Best Buy indicated that there was a 1 year manufacturer warranty on the computer at the time of purchase - implicating Dell -
- Attorney Murphy has represented that Dell has nothing to do with the transaction in an attempt to swindle this court into a decision in their favor

And what is argued for is everything they have -


For their lack of integrity and disrespect to the American Flag
